CHECK LIST

Candidate has to submit their application form along with the following documents:

- Attested photocopy of 10th certificate & marks sheet.
- Attested photocopy of 12th certificate & Marks sheet.
- Attested photocopy of Passport.
- 12 passport size photos with white background.

Student Program for Canada:

- Original, valid passport and a photocopy of the bio-data (photo) page.
- Include all cancelled or expired passports, if applicable. The passport should be valid for the duration of proposed study, as the validity of the study permit cannot exceed the validity of the passport.
- Photographs meeting the photograph specifications with a white background for yourself and each family member requesting a visa. The photographs should have your name printed on the back, dated and taken in the past 6 months.
- IELTS test results taken within last 24 months with overall band not less than 6.0, with no individual band lower than 5.5 or according to the particular institute/ program specified requirements under government norms.
- Photocopy of the most recent qualification or certificate, and most recent mark sheets (for entire program; consolidated mark sheets are NOT acceptable)
- Copy of receipts for tuition payment provided by the institution.
- Proof of funds: You MUST show the amount of \$10,000 CAD in Scotia bank Canada to cover living expenses for your first year in Canada.
- Income Tax Returns for you and your parents for the past two years.
- Reference letter from the individuals providing you financial assistance for your program. The letter must indicate their occupation and relationship to you, the number of dependents they have and their full contact details. You should also provide a letter from the employer of the individuals providing you financial assistance for your program, clearly indicating employer contact details and Full Street address of business location.
- Scholarships or any financial assistance or award from a government or other funding agency must be presented on official letter stating the full amount of the award, its duration and any governing conditions.
- Any document not in English or French must be accompanied by a certified translation.

- Any additional documents on request.
- **If Applicable** Proof of employment - letter from your current or past employer and pay slips (last 3 months). Employment letter dated within 2 months of the application indicating occupation, job description, position, salary, allowances, years of employment, and authorized leave dates.
- Copy of medical examination
- Students applying under SPP must undergo medical examination before submitting their Study Permit application by visiting one of the designated panel physicians in India.
- Applications will not be accepted under the Student Partner Program without a copy of Proof of fund.

Photo Requirements & Specifications:

Requirements

- Provide 12 photographs of yourself with your application.
- Your photographs must comply with the specifications below. If the photographs do not meet the specifications, you will have to provide new photographs before your application can be processed.
- Photographs must be printed on quality photographic paper.

Specifications

- The photographs must be identical and taken within the last six months. They may be either black and white or color.
- The photographs must be clear, well defined and taken against a plain white or light-colored background.
- If the photographs are digital, they must not be altered in any way.
- Your face must be square to the camera with a neutral expression, neither frowning nor smiling, and with your mouth closed.
- You may wear non-tinted prescription glasses as long as your eyes are clearly visible. Make sure that the frame does not cover any part of your eyes. Sunglasses are not acceptable.
- A hairpiece or other cosmetic accessory is acceptable if it does not disguise your normal appearance.

(If you must wear a head covering for religious reasons, make sure your full facial features are not obscured.)
